

#### ELIJAH BEHNKE CANDIDATE 6TH ASSEMBLY DISTRICT



# **District Attorney Greg Parker**

#### **Mission - Protect Citizens:**

Thank you for the privilege to serve as your District Attorney for the last 17 and half years. We live in extremely troubled and dangerous times. The drug culture in our community has increased dramatically over the last four to five years. We have had more over dose deaths in the past two to three years than since I've been DA. Violent crimes continue to increase in our area. Drunk drivers continue to endanger the safety of our citizens. The law abiding citizen would be surprised at how much criminal activity is happening in our community. You deserve to have an experienced District Attorney whose mission is to hold criminals responsible for the crimes they



commit in our community. As your District Attorney I have always strived to carry out my mission to protect our citizens from criminals who victimize them. I will continue to be tough on crime and at the same time administer justice fairly and impartially. Holding criminals accountable is in the best interests of our community and it is necessary to have good order in society.

#### Tough on Crime, Experienced Prosecutor & Advocate for Victims

#### Promises:

When I was elected District Attorney I promised you that I would relentlessly pursue and prosecute sexual predators, sex offenders, repeat felony drunk drivers and drug dealers. I have kept these promises over the last seventeen and a half years and will continue to do so in the future.

**High Prosecution Rate** of Sex offender Registry Violators, Traveler case - Sex Predators and Child Pornographers.

Sex offenders are required by law to report where they are living and meeting with law enforcement annually to update their information. Prosecuting sex offender registry violators is extremely important because we have to know where they are living at all times. With the proliferation of internet use by criminals in many areas, crimes that remain widespread are the criminals committing sexual related offenses. I am a member of the Internet Crimes against Children (ICAC) task force. Many years ago I trained to aggressively prosecute sexual predators that use the internet to victimize our children. The ICAC mission is to aggressively pursue child pornographers and sex predators who come to Shawano County to victimize our children. I have successfully prosecuted over 200 sex offender registry violators, sexual predator - "Traveler case" violators and child pornographers. I have obtained some of the longest prison sentences for child pornographers in Wisconsin. Recently the State Public Defender Office studied convictions of child pornographers and found that Shawano County has on average, longer prison sentences than most other counties in the State. In the last 11 years, 62 sex predators came to Shawano expecting to have sex with children. All 62 were arrested by Shawano Sheriff Department. All of the 62 predators were convicted.

**Repeat Felony Drunk Drivers -** During the last seventeen and half years my office has prosecuted over 3,000 drunk drivers. I have successfully prosecuted numerous drunk and

drugged drivers, with more than 300 of them being repeat felony drunk drivers. These convictions include 3<sup>rd</sup>, 4<sup>th</sup>, 5<sup>th</sup>, 6<sup>th</sup>, 7<sup>th</sup>, 8<sup>th</sup> and 9<sup>th</sup> offense drunk drivers.

**Drug Dealers** – I have prosecuted over 200 drug dealers who were dealing dangerous drugs in our community. I am the first prosecutor in the history of Shawano County to successfully prosecute multiple defendants all at the same time for conspiracy to deliver drugs in our community. My office and I continue to pursue drug dealers who deliver dangerous drugs - fentanyl, meth, cocaine and heroin. We have had more over dose deaths in the past three years than in all the time that I have been DA. The epidemic of lethal drug use by individuals continues to increase given the frequency of the death cases we're having in our community.

**Treatment Court – Shawano County Drug Court:** Almost six years ago, social services, Judge Kussel, probation office, me and treatment providers organized the Shawano County Drug Court. Today the drug court is at full capacity. There have been thirteen graduates. This program continues to serve qualified individuals for treatment.

**Victims of Domestic Abuse** – Many years ago I worked with Safe-Haven domestic abuse shelter to establish a program to protect victims of domestic violence so that they know what resources are available to them within our court system. Victims of domestic abuse continue to have the ability to meet with domestic violence representatives to learn all of the resources available to them after being victimized by a perpetrator.

**Homicide Cases:** I have the necessary experience in prosecuting a variety of homicide cases. I have obtained convictions in many homicides cases including First Degree Intentional Homicide, Homicide by Intoxicated Use of Motor Vehicle, Homicide by Vehicle - Use of Controlled Substance, First Degree Reckless Homicide and drug related homicides.

**Future Promises:** Shawano County is a great place to raise a family and a safe place to live. The law enforcement officers that I work with in Shawano and Menominee Counties are second to none. As District Attorney I have been honored to be part of the team effort being carried out on a daily basis. I promise to continue to aggressively prosecute sex offenders, child sex predators and child pornographers. I promise to continue to be tough on drunk and drugged drivers and drug dealers in our community. Finally, I promise to continue to be strong advocate and supporter of victims of crime.

I will continue to keep our community safe for you and your family. I want to keep Shawano a great place for you to live and raise a family so I ask for your vote to continue the fight to keep our community safe for four more years. Thank you and God bless you.


We hauled out 2 tons of garbage. We arranged and moved all remaining items into the Western portion of the back room.

In many cases, these smugglers swindle young men and women into sex trafficking rings.

An increase in fentanyl and sex trafficking, while border infrastructure gathers dust and rust. This is Joe Biden's legacy.


The results are promising - our campaign continues to build momentum throughout the district. My family and I are amazed at the outpouring of support and the fantastic people we continue to meet.


